	any promotions to the non-teaching employees based on any retirement vacancies and thus on compulsion the authorities of the Institute have carried out the exercise of promotions.

	Ministry of HRD. Therefore the proposal for promotions for the non-teaching
	employees on the basis of old REC rules may be sent to ministry for
	sympathetic considerations.
