Agenda Item 6: Co-Teaching in elective courses

The item was presented by Dr. Anu Mary Chako. Offering collaborative electives for UG and PG courses in collaboration with scientists / SMEs is an initiative taken by the Center for Industry Institutional Relationship (CIIR) and subsequently proposals were requested from the faculty members through email. The DCC noted that interested faculty members may recommend co-teaching proposal details.

Agenda Item 7: External Co-guide for Ms. Akhila V H

The item (Annexure II) was presented by Dr. Anu Mary Chako. The DCC approved the request, noting that no additional financial commitments are involved from the Department/Institute.

Further, the DCC resolved that the recommendation of the Doctoral Committees of the PhD students of CSED regarding academic matters such as external interactions, co-guideships and other matters pertaining to Ph.D students of the department, without any financial implications from the Institute/Department, may be approved/recommended by the HOD without further placing the matter in DCC, and that this minutes of the present agenda item may be considered as the endorsement of the DCC on all such matters in the future.

Agenda Item 8: (i) General Guidelines for waiving prerequisites for elective courses.

(ii) Ratification for recommendation regarding CS 4050 including additional list of students received.

DCC resolved to recommend the list of students (Annexure III) recommended by Dr. Sheerazuddin for enrolment to the elective CS 4050.

Further, the DCC resolved to authorize the HOD to recommend and forward any such future cases of requests from students for wavering prerequisites for course enrolments to Dean Academic without further placing the matter in DCC, provided that the course faculty recommends the case after verifying the background of the students and recommends their enrolment. The DCC resolved that the minutes of the present agenda item may be considered as the endorsement of the DCC on all similar cases in the future.

Agenda Item 9: AOB: (i) Introduction of biometric attendance system as per institute directive.

HOD CSED informed the DCC that a biometric attendance system will be introduced in CSED. The biometric system for Research Scholars, PG students, Contract/Adhoc Staff/faculty will be placed in the CSED Office and for permanent staff and faculty will be placed in a location accessible throughout the day, including the time outside office hours.
