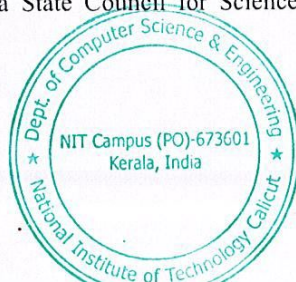

CSED, NITC. The request was approved on 02/02/2022 subsequent to communication for faculty members over email. The DCC discussed and ratified the approval.

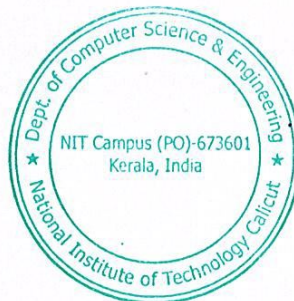
Agenda Item 5: Requests from S6 MCA students to join for internship in industry
