#### **Sub: - Academic Fee payment for Monsoon semester 2023-24**

The fee payment and registration to the Monsoon Semester 2023-24 is to be done through IMS portal. Fee demand for individual students are available in the student IMS Portal and can be accessed using the link: <https://ims.nitc.ac.in/Default/Pages/NITC/LandingPage.html>. Please note that there may be a 24-hour delay to reflect your payments made in IMS.

#### **Instructions to Avail Income-based Fee Concession (B.Tech/B.Arch JoSAA only):**

B.Tech/B.Arch students (admitted through JOSAA & belonging to General/EWS/OBC/OBC-NCL) intending to avail annual income-based fee concession are required to first complete the **Annual Income Declaration** in their IMS page, **by uploading a valid income certificate** before proceeding to the fee payment. Income certificate must be the one issued on or after **1<sup>st</sup> April, 2023** (as per the circular issued by AR(Academic) on 7<sup>th</sup> June 2023) and will be considered as valid for this financial year only. **The income declaration option will be available only once in a year, at the time of Monsoon registration.** The income certificate, in original, must be produced to the Academic section for verification, based on a schedule to be notified later. Uploading invalid/false documents will lead to cancellation of registration to the semester and payment of a penalty of Rs 10000/- (Rupees Ten Thousand Only).

#### **Instructions for ICCR/Egrantz/SII Students:**

- **ICCR (Applicable for 2022 Admission):** Out of the total demand students have to pay **Rs 16,936** (Misc. fee plus hostel seat rent) in IMS and for the balance amount they need to select 'fee waiver' and choose 'ICCR fee waiver'.
- **ICCR (Applicable for other than 2022 Admissions):** Out of the total demand students have to pay **Rs 4,936** (Misc. Fee component) and for the balance amount they need to select 'fee waiver' and choose 'ICCR fee waiver'.
- **Egrantz (Applicable for 2022 Admission):** SC/ST/OBC(H)/OEC from Kerala who have applied for Egrantz and submitted the documents to the academic section, need to pay Rs.9,000, hostel seat rent component through IMS. For waiver of Miscellaneous fee, they should choose E Grantz option in fee waiver and submit.
- **Egrantz (Applicable for other than 2022 Admissions)-** SC/ST/OBC(H)/OEC from Kerala who have applied for Egrantz and submitted the documents to the academic section, need to choose Kerala Egrantz Applied in the "Fee Waiver" option and submit.
- **SII SAARC and Non-SAARC** students with scholarship - Out of the total demand shown in IMS, the students shall pay the balance after deducting the eligible scholarship amount of Rs1,25000/- [scholarship to be converted to INR using the rate 1 USD = 82 INR] and also choose SII in the "Fee Waiver" option and submit.

It is mandatory for the students availing education loan to enter the relevant details in IMS. Details if not entered properly in IMS will lead to late fee and/or cancellation of semester registration. The following details regarding the transaction are required to be entered in IMS portal, failing which your fee payment will not be approved.

1. Account to which fee is transferred
2. Transaction id/Journal No/D.D No (Demand Draft in favour of Director NIT Calicut)
3. Date of Transaction
4. Amount Paid

Please note that Bank Loan amount can only be adjusted against their fees and Institute is not authorized to refund any amount. For those who are availing the Educational Loan, this notice will constitute as Demand for Fees for the Monsoon Semester 2023-24. The Demand Draft (only applicable in case of Education Loan) towards the fee should be in favour of "Director, NIT Calicut" and towards Hostel Fees, if any, should be in favour of "Chief Warden, NITC Hostels". The Demand Draft towards the fee has to be submitted to the SBI NITC Branch. The transaction details and journal number needs to be entered in IMS.

**Timeline for payment of fee is as follows:**

19 <sup>th</sup> July 2023	Starting date for fee payment & Submission of Annual Income Declaration in IMS for those claiming income-based fee reduction
28 <sup>th</sup> July 2023	Last date for fee payment
18 <sup>th</sup> Aug 2023	Last date for fee payment with a fine of Rs. 2000/-

Note that the fee payment is a mandatory requirement for academic registration to Monsoon 2023-24. Those who do not complete the fee payment in the time window provided will not be allowed to register for Monsoon semester 2023, and they will be allowed to register only after paying the late registration fee along with Academic fee.

Note: *Fee payment through third party or Direct Transfer to Institute Account or through SBI Collect will not be accepted. Such payments, if any, made will not be adjusted to the fee due and will be refunded to the student upon submitting proof of such payments to the Academic section in due course of time.*
