Selected candidates will be receiving a separate email (in their registered email id) detailing the online process to be completed in our Institute Management System (IMS), including fee payment, before physically reporting to the campus. Your admission will be confirmed upon verifying the following certificates in original.

1. Proof of Date of Birth (SSLC or equivalent certificate)
2. Degree certificates and consolidated/semester wise mark list for UG and PG programmes
3. Candidates who have appeared for their final semester PG examination and are awaiting results have to produce the course completion certificate from the Head of

the Institution stating that he/she has appeared/appearing for the final semester examination.

4. Photo ID Proof (Aadhaar Card or any other relevant document)
5. Proof of National Level Eligibility Tests/Fellowships (GATE/ UGC/ CSIR/ NBHM/ JRF/ DBT/ KSCSTE etc.)
6. For candidates belonging to SC/ST category, Community Certificate from a competent authority (**not below the rank of Tahsildar**).
7. Those who have claimed the Economically Weaker Sections (EWS) reservation at the time of application has to bring the EWS Certificate issued by a competent authority (**not below the rank of Tahsildar**) indicating the financial status for the financial year ending March 31, 2023 (the certificate should have been issued on or after 1st April 2023). The financial year shown in the EWS certificate should be 2022-23 and the year of validity should be 2023-24.
8. Those who have claimed the OBC Non-creamy Layer (NCL) reservation at the time of application has to bring the OBC NCL Community Certificate issued by a competent authority (**not below the rank of Tahsildar**) indicating the status regarding Creamy Layer based on the financial year ending March 31, 2023 (the certificate should have been issued on or after 1st April, 2023).
Candidates, who fail to produce the relevant category certificates as mentioned above, at the time of admissions, will lose their claim for reservation. Such candidates will be subsequently considered under the OPEN (GENERAL) category and they may even lose their allotted seat.
9. For candidates selected under scheme III, a **Sponsorship certificate**, signed by the Head/Competent authority of the Institution/organization/Company in the prescribed format. Such candidates must also produce the **Relieving Certificate**, issued by the sponsoring authority on their letterhead in the prescribed format.
10. For candidates selected under the external registration (Schemes V & VI), a **No objection-cum-Experience certificate** signed by the Head/Competent authority of the Institution/organization/Company in the prescribed format.
11. For candidates selected under scheme IV (i.e., internal candidates), a **No-Objection Certificate** from the Head of the Department/School.
12. Recent PHOTOGRAPH (Passport)
13. Conduct/Character certificate from the **Head of the Institution**/Organization last attended/working **or Gazetted Officer** issued within the last six months (i.e., issued on or after 1st August 2023)
14. Transfer Certificate issued from the institute last studied/attended. You can submit the Migration certificate instead of the Transfer certificate, only if the Institute is not providing the same. In case you are submitting the migration certificate we need proof issued from the institute last studied/attended stating that they do not issue a transfer certificate.

15. One Photostat (self-attested) copy of the certificates mentioned in sl. Nos (1)-(5) above.
