E-Grantz District Office, Kozhikode has given approval of the fee structure for the year 2023-24 in respect of the OEC, OBC, OBC(H) and General Categories for all the courses at NITC. Kerala State Students who belong to OEC, OBC, OBC(H) and General Categories who have taken admission for FIRST YEAR in the 2023-24 Academic Year are hereby instructed to submit the application online or through the nearest 'AKSHAYA KENDRA' immediately subject to their eligibility.

Kerala State students who belong to OBC and General Categories who had taken admission for various courses (UG & PG) during the year 2022-2023, and were not able to submit their application as the fee approval was not given for 2022-23 Academic year can submit their application as '**2<sup>nd</sup> year**' for the year '**2023-24**' and submit their application now. (See Annexure III)

No income limit for OEC applicants, Income Limit for OBC H is 6 lakhs and for OBC and General Applicants, the limit is 1 lakh.

Applicants have to upload the required digital documents while submitting the online application. All the documents should be less than 150kb in size.

PRINT OUT OF THE ONLINE APPLICATION (duly signed by the student and parent) along with the filled in application of NITC should be submitted to the Academic Section NIT Calicut along with the documents in the Annexure I, for verification at Institute level and onward submission to the concerned Departments, Government of Kerala.

If the District Development Office does not sanction the scholarship/educational concession, students will be liable to pay the applicable fees at the prescribed rate with fine and will not be eligible for free hostel facilities, wherever applicable.

12. Annexure II - *Aadhaar seeding is a mandatory requirement for DBT transactions, and failure to complete this process may result in delays in receiving your scholarship funds.*  
Aadhar Seeding authorization from the bank attached(Annexure II). Aadhar Seeding can be done from any branch of your bank.

*Note: The E-Grantz applications received in the Academic will be verified only if the original Transfer certificate is submitted to the Admission office of the Institute.*

The filled in applications (Hard Copy) with all relevant documents should be submitted to the E-Grantz counter GA2 at Academic Section.

## **Important Instructions for submitting the online application for E Grantz**

All students are hereby advised to read carefully instructions before submitting the application in the E Grantz portal.

1. The mobile number should be unique for the one-time registration and **should not be changed** until the end of the course.
2. The name should be entered in block letters as per the admission record of NITC.
3. NITC Institute Roll Number should be entered as **admission number** in the E Grantz Portal.
4. Passport size photo should be uploaded as profile picture while submitting the application in the E Grantz portal.
5. For 2023 Admission Students, the course year should be entered as **1** (one) and for 2022 Admission, course year should be entered as **II** (two) in the E Grantz portal for the Academic Year 2023-24.
6. The Income category of students submitted in the E Grantz during the first year will not be able to change until the end of the course. Any additional fee payable by the student due to the change of annual income should be paid by the student directly to the Institute as the variation of fees cannot be claimed through E Grantz in the subsequent years.
7. E Grantz scholarship is for yearly wise. Hence the claims and approval of the fees are done yearly. Students must make sure their applications are renewed year-wise by checking the status of your application in the **Track** of E-Grantz portal.
8. Government has introduced Direct Benefit Transfer (DBT) for disbursement of scholarship amount to students. The examination fee and non-refundable miscellaneous fee credited to the students account by DBT has to be transferred to Institute account by the students within the period of ten days.
9. Students are requested to check their bank accounts at regular intervals to check whether the Scholarship amount has credited directly to the students account by the E-Grantz Department.
10. As per the Institute rules, a student should not avail more than one scholarship at a time. If anyone found availing more than one scholarship action will be taken as per the rules from time.

**Any correction/editing of data after final submission of application in the E Grantz portal will rewrite the data in the data base and may lead to cancellation of scholarship.**
