# MINUTES OF THE 23<sup>rd</sup> MEETING OF THE BOARD OF GOVERNORS OF NATIONAL INSTITUTE OF TECHNOLOGY CALICUT HELD AT 3.30PM ON 24<sup>th</sup> JULY 2013 AT HOTEL CLASSIC INN, BANGALORE

The Hon. Chairperson, Board of Governors, NIT Calicut called the meeting to order at 3.30PM and welcomed the members. The following decisions were taken at the meeting.

Decision	The BoG took note of the recommendations of the FC and approved the annual accounts for 2012-'13.		
	It observed that once audit of the accounts is completed, the annual accounts may be forwarded to the

#### Decision

Director informed the meeting that the Institute had conducted interviews for promotion of faculty under the one time CAS approved by the MHRD. From the applicants, all faculty members satisfying the eligibility norms as on 30.04.2013 were called for the interview. Besides the above, four other faculty members, whose applications were rejected by the scrutiny committee, were also called for the interview on the basis of an order of the Hon. High Court of Kerala dated 27<sup>th</sup> June 2013. At the outset, Dr. Santosh. G. Thampi, Registrar, and Dr. Sameer, S. M., Member, BoG, requested that they may be permitted to stay away during the discussion on this item as they had attended the interview. The BoG allowed them to stay out and Dr. R. Vijayakumar, Dean (Faculty Welfare) was called inside to assist the Director in presenting the minutes of the Selection Committees. The Director along with the Dean (Faculty Welfare) presented department wise the minutes of the selection committees constituted for promotion of faculty under CAS. The selection committees had proposed that the following faculty may be promoted to the posts noted against their names w.e.f. their respective date of eligibility, worked out by the scrutiny committee. The details pertaining to dates of eligibility were also presented before the BoG. The recommendations of the FC in this regard were also presented before the BoG. The following important features regarding the dates of eligibility were noted by the BoG.

- 1. All promotions are based on the norms followed for the last CAS interviews in the Institute. Dean (FW) explained to the BoG that as per the above mentioned norms, the eligibility period for moving from Lecturer to Lecturer (SS) is 6 years for those with BTech, 5 years for those with MTech and 4 years for those with Ph.D. To move from Lecturer (SS) to Lecturer (SG), the eligibility period is uniformly 5 years as on the cut-off date. For movement to the post of Professor, the eligibility period is 8 years as Assistant Professor. (Service as Lecturer (SG) will be counted towards the 8 years, from the date on which the candidate acquires Ph.D).
- 2. All the dates of eligibility are on or before the cutoff date (30-04-2013).
- 3. Correction of CAS anomalies on the date of eligibility had been accommodated, as directed by the BoG (BG17.06).

Dean (FW) also requested the BoG to consider case of faculty members who have put in teaching service in Government Colleges and/or Government aided Colleges. Mr. Satpal Sharma representing the MHRD said that a uniform decision across all NITs is required in the matter and until such time a decision is taken, the request cannot be considered. Taking note of this view of the MHRD and the recommendation of the FC, the BoG decided not to consider the case of faculty members who have put in teaching service in Govt. Colleges and Govt. aided Colleges for the time being. The BoG also decided that this can be taken up after a uniform policy in this regard is evolved at the NIT Council.

The BoG accepted the recommendation of the FC to approve the recommendations of the selection committees for promotion under CAS and decided to grant promotions to those faculty members recommended for promotion by the selection committees w.e.f. the respective dates of eligibility. The BoG also took note of the recommendations of the scrutiny committee regarding dates of eligibility. The BoG approved the recommendation of the FC to fix their pay notionally from the respective dates of eligibility. The final selection list of faculty members for promotion under CAS in various Departments along with their dates of eligibility as approved by the BoG is as follows:

	The BoG agreed with the recommendation of the FC that a performance appraisal has to be carried out		
	in the case of these persons before they can be considered for upgradation. The BoG instructed the		
	Director to constitute an in house committee for this purpose and submit its recommendations to the		
	Hon. Chairpserson, BoG. The BoG authorized the Hon. Chaiperson, BoG to take an appropriate		
	decision on this based on the recommendations of the Committee and the Director.

The BoG discussed the proposal presented before it to declare the probation of three faculty members -

Dr Vari Sivaji Reddy (Physics), Dr N Selvaraju (Chemical Engg.), Dr Sunitha (SoMS) - who were
initially appointed on contract and subsequently regularised, subject to satisfactory completion of
probation for one year from the date of regularisation. The BoG accepted the recommendation of the
Director that these three faculty may be deemed to have completed probation satisfactorily and this be
declared.

# Subject BG23.08 Adoption of 4-tier flexible faculty cadre structure in the Institute with effect from 01.08.2013

### Decision

The BoG discussed the proposal of the Institute based on the direction of the MHRD that after the onetime CAS, all NITs shall adopt the flexible 4-tier faculty cadre structure as decided by the NIT Council in its 3<sup>rd</sup> meeting by adoption of the MHRD guidelines by way of resolution by the BoGs. The selection norms for various positions under the flexible 4-tier structure will be issued by the MHRD in due course. MHRD has also instructed that all NITs shall send compliance report to the Ministry by 30<sup>th</sup> April 2013. The BoG approved adoption of the decision of the NIT Council to shift to the flexible 4-tier faculty cadre structure from 01.08.2013 and directed that a compliance report may be sent to the MHRD.

# BG23.09 Recruitment of Assistant Professors by special recruitment to fill up backlog vacancies of SCs, STs, OBCs and PWDs and by open selection to unreserved vacancies

#### Decision

The BoG discussed and accepted the proposal submitted by the Institute to conduct direct recruitment to the 37 vacant faculty positions of Assistant Professors with AGP `6000/- as per the details furnished in Table below.

# Subject BG23.10 Consideration of the report of the committee constituted for looking into the complaints in connection with the promotions granted to non-faculty staff in January 2013 and related matters

#### Decision

The BoG agreed with the recommendation of the FC that the report of the committee has to be examined in detail and legal opinion has to be sought in this regard, taking into account the prevailing

situation in the Institute. It accepted the recommendation of the FC that the matter can be considered and decided in the next meeting and deferred a decision on the item. Registrar informed the meeting that the Hon. High Court of Kerala had passed orders on 9<sup>th</sup> July 2013 in a case filed by Sri. M. V. Prasad, U.D. Clerk, directing the BoG to consider his representation raising grievances against the promotion granted to Sri. A. Balan and pass appropriate orders thereon as expeditiously as possible, at any rate, within a period of one month receipt of a copy of the judgment. He also informed the BoG that a certified copy of the judgment has not yet been received although a copy of the judgment was delivered to the Institute on 15<sup>th</sup> July 2013. The BoG considered the representation and directed that the Director shall set up a committee to examine the grievances of Mr. M.V. Prasad against the promotion granted to Sri. A. Balan and report on the same to the BoG to enable taking a final decision in the matter. The BoG also instructed to contact the Legal Counsel and ask them to do the needful to seek extension of time from the Hon. High Court of Kerala to decide on the matter.

# BG23.11 Request for permission to engage the services of Apprentice Trainees for one year on contract basis on successful completion of their apprentice period

Decision

Taking into account the large number of posts of non faculty lying vacant, the enhanced workload due to increase in student intake and the request of the Institute, the BoG accepted the recommendation of the FC that on successful and satisfactory completion of apprenticeship by apprentice trainees with Diploma in Commercial Practice (DCP) qualification, being engaged in various offices in the Institute from the Central Board of Apprentice Training, they may be engaged for a period of one year as adhoc office assistants on the same remuneration and terms and conditions as the adhoc office assistants engaged through a test and walk in interview. The BoG decided that this will be effective from the batch of apprentice trainees completing their apprenticeship in June-July 2013. Further, the BoG also accepted the recommendation of the FC that those adhoc office assistants who had to be engaged for a few days on daily wage basis after completion of their tenure due to delay in fresh engagement on account of administrative exigencies may be paid for the number of days for which their services were engaged on daily wage basis.

# BG23.12 Requests for engaging the services of four retired staff to complete work in connection with the issue of Form 16 and regulation of pension of CREC pensioners as per Kerala State Pension Revision Orders

Decision

The BoG accepted the recommendation of the FC to permit engagement of three retired ministerial staff conversant with pension fixation and preparation of arrear bills for three months on a consolidated remuneration of `15000/- each to complete the works in connection with regulation of pension of CREC pensioners as per the Kerala Govt. pension revision orders. Based on the recommendations of the FC, the BoG also permitted engagement of the services of Sri. K Mohandas, Retired Junior Superintendent, for a period of six months to rectify mistakes and complete works pending in

	connection with income tax deduction and to sort out outstanding problems with the Dept. of Income
	Tax for six months and directed that payment to him may be regulated as per the rules of the GoI.

	The BoG accepted the recommendation of the FC that a decision in this regard cannot be taken at this
	stage as Mr. Satpal Sharma, Under Secretary, IFD, MHRD, informed the meeting that conflicting
	judgments have been delivered by some courts and tribunals in the matter and the matter is before the
	Ministry of Finance for a decision. Hence, the BoG decided to await the decision of the Govt. of India
	in this regard.
	(iii) Request of the Officer on Special Duty (OSD) to permit to opt the scale of pay of Deputy
	Registrar
	The BoG concurred with the recommendation of the FC that this request could be granted only if
	provision of such an option had been mentioned in the request of the Institute seeking deputation. In the
	absence of such a provision, the BoG decided that the present practice will continue. The Institute shall

keep provision for such an option in future requests for filling up of posts on deputation basis.

#### (iv) Request for permission to appoint an MIS Officer and two support staff on adhoc basis in the Office of TEQIP

The BoG approved the recommendation of the FC to permit appointment of an MIS Officer, two support staff and one data entry operator on adhoc basis for the duration of the project in the Office of TEQIP to enable the Coordinator, TEQIP II, to carry out day to day activities connected with the implementation of the project. The remuneration of these staff will be as follows: MIS Officer -`40,000/-p.m., support staff and data entry operator - `10,000/-p.m. The expenses incurred in this regard will be booked against TEQIP grants.

#### (v) Review of progress of ongoing civil works in the campus

The Registrar submitted before the BoG details of ongoing civil works in the campus including present status prepared by the Dean (P&D). The BoG took note of the same and directed to take immediate

action to accelerate ongoing work, and ensure strict quality control, and monitoring of the progress of works. The Registrar informed the meeting that a letter had been received from the Deputy Chief Engineer, Kerala State Electricity Board in connection with the proposal for a 33/11kV substation, requesting to provide about 30 to 50 cents of land for this purpose. As per section 6(2) of the NIT Act 2007, prior approval of the Govt. of India is required for transfer of immovable properties of NITs. The BoG accepted the recommendation of the FC in this regard and approved the proposal to request the Govt. of India to permit transfer of upto 50 cents of land for the purpose of establishing an electrical substation in the campus.
